Chevalier Investiture – Page 1 of 8

RW1a Room is set up as on Diagram One, except the only stations necessary are those of the Required Parts (GC, CW, CS, GMar, and GCh).

0221 Open Bible is lying near center of Altar.

0221 School books on Northeast corner of Altar.

GI0320 If flowers are used, they shall be placed around Bible, not on it.

GI0321 If Bible marker is used, the DeMolay emblem upon it, if any, should face toward the West side of Altar whether Bible is open or closed.

GI0324 If DeMolay emblem is on Altar cloth, if used, it shall be on West side.

0222 A lectern placed in the East, to the South of the GC.

GI0316 A Gavel should be on the GC's pedestal.

0225 If used, seven candlesticks placed as indicated on Diagram One.

0225 If used, the national flag in a standard placed as in Diagram One.

0226 If used, Chapter banner in a standard placed as in Diagram One.

GI0402 No person shall pass between Altar and East except when so instructed.

- GI0404 All floor movements should be made in clockwise direction except when specifically noted otherwise.
- RW1b Parts are outside the door at the beginning of the ceremony.
- 0234 The officers enter single file as follows: GMar, GC, CS, CW, and GCh.
- RW1c Procession is not required to stop and/or face station when dropping off officers, but may do so.
- 0235 GMar leading the procession moves C E V T C E V Z X dropping off the GC, CS, CW and then GCh at their respective stations.
- GI0428 If Grand Marshal carries baton, one end of baton should be in his left hand, the other end should be tucked under his left arm.
- 0236 GMar faces West.
- 0238 GC: + * (rap) +
- 0239 All except GC sit down.
- GI0419 When GMar is addressed by GC, he shall rise immediately and face GC. No other salute of any kind shall be given.
- 0305 GMar moves X Z T, then to the place where the designates are seated.
- RW1j GMar indicates that he is assisting or directing designates.
- 0306 GMar conducts them to point U. facing East.

- 0716 As GCh leaves station all DeMolays and Chevaliers in East and CW and CS descend to floor level.
- 0718 All DeMolays and Chevaliers kneel in unison as Chaplain kneels.
- 0728 All + Amen +
- 0729 GCh and all DeMolays and Chevaliers except designates rise.
- 0730 GCh takes one step backward away from Altar, faces North, moves J K V Z X, faces west.
- 0732 As GCh leaves Altar all DeMolays and Chevaliers who were in East (except GC) and CW and CS return to daises.
- 0732 Lights raised to full.
- 0733 GC moves to point between designates and candle 4, faces designates.
- 0804 GC + By virtue ... you will arise. +
