- RW1a Room is set up as on Diagram One, except for stations.
- 0206 Gavel is on Master Councilor's pedestal.
- 0207 Holy Bible is open on the Altar.
- 0207 School books on northeast corner of Altar.
- 0208 One white flower tied with royal purple ribbon lying on Master Councilor's pedestal.
- 0210 One each: RD lapel pin, RD citation and RD card, all on a separate pedestal just South of Altar and candle 7.
- 0206 Holy Bible is open on the altar.
- 0207 Schoolbooks are on the northeast corner of the altar.
- 0211 If used, the candles shall be arranged about and to east of the altar in accordance with Diagram One.
- GI0320 If flowers are used, they shall be placed around Bible, not on it.
- GI0321 If Bible marker is used, the DeMolay emblem upon it, if any, should face toward the West side of Altar whether Bible is open or closed.
- GI0324 If DeMolay emblem is on Altar cloth, if used, it shall be on West side.

GI0314 If used, National flag and Chapter banner are placed as in Diagram One.

GI0402 No person shall pass between Altar and East except when so instructed.

GI0404 All floor movements should be made in clockwise direction except when specifically noted otherwise.

RW1a4 Parts are seated in respective stations at beginning of ceremony.

GI0421 All officers stand when speaking.

0222 Master Councilor: + Brother Marshal +

GI0419 Marshal rises immediately and faces Master Councilor.

0224 Marshal moves X Z T, thence to place where designates are seated....

0225 ...and conducts them to point U.

GI0426 When Marshal conducts a person, he shall use his right arm and hand to take hold of person's left forearm and wrist as in Figure 2.

GI0428 If Marshal carries baton, one end of baton should be in his left hand, the other end should be tucked under his left arm.

0225 Marshal and designates face East.

RW1e Marshal makes all verbal responses for designates.

- RW1f ...and shakes hands with Marshal.
- 0509 Master Councilor returns to O...
- 0510 ...thence to East, moving O U X.
- 0511 Master Councilor: + * (rap) +
- 0514 Marshal and designates move J K V U...
- 0514 ...face East.
- 0528 Master Councilor moves X U...
- RW1f ...presents flower to Marshal...
- 0528 ...returns U X...
